



Welcome – to all residents of Clearwater Beach. Summer time, with boating and beaches, is here once again. The Reservation is in very good shape, due in particular, to the efforts of our directors.

- The channel has been dredged once again. This was necessary due to several nor'easters which filled it with sand.
- We have repaired all of the lights and water pipes, which were damaged over the harsh winter months.
- The beach was cleaned and raked during the end of March. We will try to have this done again before the birds arrive.
- We have new electric gates, which have a longer delay time to allow boats to pass through.
- We have put out bids for leveling and straightening the roads and parking area, which was damaged by vandals.
- We intend to paint the two small maintenance buildings on the Reservation, as well.

On Saturday after the 4th of July, July 7th, we will host our annual picnic. (The next day, Sunday, July 8th, will be the rain date.) We will need volunteers to come forward to set up and break down tables and grilles at the picnic—also to clean up the area later on. Please call Don Schrage at 324-5746 to help with this.

So far we are sure of three lifeguards for the beach, but we will need two more. Applicants must be qualified and willing to work on weekends. We must rebuild the two lifeguard stands, which were smashed by the winter storms.

Once again, we must remind everyone to abide by the regulations of the Town of East Hampton and of Clearwater Beach Property Owners Association when enjoying our Marina and Reservation.

Boaters are not to go faster than five (5) m.p.h. and make no "wake" in the channel. Violators will be asked to remove their vessels from our Marina.

Please!!! No refuse is to be thrown into the water at any time. Also, there is no cleaning of fish on our property. These rules are regulated by the Department of Environmental Conservation of the State of New York.

Problems with noise levels in the community and/or overcrowding in residences, please notify the Code Enforcement Bureau of the Town of East Hampton or the Police Department.

Garbage cans placed around the Reservation are <u>NOT</u> to be used for household trash. Violators will put their reservation Privileges in jeopardy.

Please remember that there are no dogs allowed on the Reservation from Memorial Day to Labor Day.


Finally, if you should observe any vandalism taking place on the Reservation, please notify the Police or a member of our Board.

FROM THE DESK OF THE EXECUTIVE SECRETARY

I thought we would never get warm weather but thank God, Spring is here at last! I have had some members phone and complain they didn't get their membership fee invoice or newsletters and on further investigation, we found that they never gave us their address change. That will do it every time. So if you are going to move in the future, please forward us a line notifying us of your new mailing address and make sure the Post Office is also informed so they can forward your mail to you at the new address.

Members are also phoning for a boat slip and seem disappointed when we have to inform them that the marina was filled by February 15th this year. If you have a boat or are purchasing one in the near future and you wish to obtain a slip in the marina next year, remember to request a boat slip application around the middle of December, fill it in and send it to us with the application completely filled and all the necessary documentation and fee by February 15, 2008 and you will almost be assured of obtaining a slip. If you have a computer and a Internet connection, you can go to our website- cbpoa.net- and download an application from that site, but not until after December 15th 2007. Remember members always have preference over sponsored members <u>only</u> if they have their boat slip applications in by the deadline date of February 15th. After the Dockmasters work on boat slip assignments, which is usually by the end of February or beginning of March, then members lose their preferential treatment in regard to boat slips. This year we had 11 members who were on the waiting list for a slip cancellation.

Now a reminder about gate cards: Gate cards are a one time issue and are validated upon payment of the current year's maintenance fee if you are up to date. Members are allowed a maximum of three (3) gate cards per paying lot, one is free with the initial membership fee and you may purchase an additional 1 or 2 at \$3.00 per card by phoning me at 631-907-9032—but **please not before 10:00AM or after 6:00PM.** However be forewarned, if you take the maximum of 3 cards and you lose them and wish to replace any of them, you will be charged \$50.00 for each replacement card. So be careful and take care of those cards.

To those of you who have not yet sent in your maintenance fees, why not sit down and write that check right now. It takes a lot of money to keep the Reservation in the great shape that it is in and our Directors are not able to do the physical work so we have to hire outside contractors to do the work and as you must know that is very expensive. So get those fees in now. Also remember, if you card(s) are broken or do not work phone the Gatemaster, Jack Schilling at 324-3439 and he will replace those defective cards for free. Another reminder (gee, seems like I'm full of reminders), don't forget to use those proxy vote cards to vote for the Directors running for office this year and if you can, try to make the annual membership meeting on Saturday July 28, 2007 at the Springs School. from the Dockmaster —

The 2007 boating season is under way. We have received additional applications over and above the number of slips available for this season. One boater has given up his slip and the first person on the waiting list has been notified.

Although the majority of the boat applicants submitted the required data with their application, a few members did not. Their application was returned to them for updated material. It is important to note that these people were not given a priority number for a slip until all data had been submitted. Some applicants waited too long to complete their data requirements so that they missed out on obtaining a slip. There are four important things to remember when submitting your application:

- 1- Submit a copy of the boat registration
- 2- Submit a Certificate of Insurance or copy
- 3- Fill in the emergency data area in back of the application
- 4- Sign your application below the emergency data.

There are some members of the community who don't realize that our marina is very desirable and wait too long to apply for a slip. It is strongly suggested that the application be sent before Feb 15. We have 900 community members and there are 119 boat slips. Applications received before Feb 15 will have the best chance of keeping their last season's slip if desired. There are many boat owners in our marina who are purchasing larger boats and this has resulted in a change of slip assignments for some boaters. The assistant dock master and I tried to make a best choice for a boat slip assignment. At the time we made slip assignments all CBPOA members were given a slip. Once again, some CBPOA members submitted a late application and therefore had to be placed on the waiting list.

We urge all of our boaters at the marina to check their boat after a rain storm or have someone do it for them to avoid a possible pump out fee. The CBPOA policy of notifying boat owners if their boat is in danger of sinking will be in place. If the boat owner does not respond, we will contact a marine service to pump out the boat at a cost to the boat owner. CBPOA will pay the marine service for the pump out and in turn will bill the boater. Failure to pay this bill will result in a denial of a slip in the future. The pump out fee will be set by the marine service. To avoid any pump out cost, the boat owner should periodically check the floating condition of their boat particularly after a rain storm. Please call the Dock Master (324-5364) or Assistant Dock Master (Bruce Hoek - 324-0810) for boating problems at our marina.

At our main bulkhead, where boaters had to dock broadside to the bulkhead, boaters will be able to dock their boats stern-in. The new arrangement will permit boats to be away from the channel cut to "Gardiners" bay where the water is sometimes extremely rough. Our security system will be operational this boating season. Although installed to protect the reservation and marina, the system can be an aid for boaters at the marina. If you have experienced problems at the Reservation, please inform our secretary Mr. Rod Grille, the Assistant Dock Master or myself. This should be done within a few days. Security recordings are discarded after several days and therefore are not available for playback.

As a reminder, boat slip applications can be downloaded from the CBPOA web site. You must make sure to download the application and the emergency data form. The 2008 boating season application will be placed on the web site on/about Dec 15 2007. To access the CBPOA web site log on to www.cbpoa.net. The marina rules and requirements for boaters are also posted along with other pertinent marina information.

On an on-going basis, we are tracking boat registrations to ensure that all boaters at our marina have valid registrations. Please make sure that you submit a copy of your renewed registration if it expired during our current boating season. We use your registration to validate that all boats in the marina are marina members.

A free Vessel Safety Inspection, performed by a member of the East Hampton Power Squadron, will be available for this 2007 season at our Marina. If you wish to have your boat inspected, please call me at 324-5364 to make an appointment for this inspection.

After December 15, 2007 you may obtain your 2008 boat application and get this application in early (before Feb 15, 2008). On behalf of the Board of Directors we wish everyone a safe boating season.

WALK WITH THE BIRDS

Last year's birding event at Clearwater Beach with Joe Giunta was a huge success, so this year we have asked him to lead 2 bird walks. The "Breeding Birds of Spring" will be held on Friday, June 22 at 7pm and "Early Bird Migration" will be held on Friday, August 10 also at 7pm.

Joe, a native New Yorker, is the Birding Instructor for the Brooklyn Botanical Gardens and has led bird walks for the Nature Conservancy, the South Fork Natural History Society and is a NYC Audubon volunteer. Joe recommends 8x40 binoculars and also recommends that you bring a bird guide, preferably "Peterson's Field Guide to Eastern Birds". There will be a small fee of \$7 for each walk.

Donn Hein, a distributor of old and rare wines, will join us on **May 18** at 7pm to discuss vintage wines of the Rhone Valley. The focus will be on the wine industry, from vineyard to the retail store. The fee is \$20; we will provide complementary food tastings.

Then on **June 1**, Joanne Braxl of Race Lane Wine & Liquors will join us at 7pm to take us through a tasting of distinctive "Summer Whites". The fee is \$12; we will provide complementary food tastings.

And finally, Donn will return on **August 5** at 6pm when we will move northward to the Cote d'or and learn about red and white Burgundies - Chardonnays and Pinot Noirs. The fee is \$20; we will provide complementary food tastings.

C.B.P.O.A. PICNIC AREA

Guidelines for Reserving Area

- 1. Send completed form plus check to George Lombardi, 3 Haynes Lane, East Hampton, NY 11937; phone: 324-5998.
- 2. Maximum number of 100 people allowed per reservation.
- 3. Cars must be parked in the paved parking lot.
- 4. C.B.P.O.A resident making the reservation is responsible for the conduct and actions of all guests and for the Cleaning Up of the area after the affair or party. TRASH MUST BE CARTED AWAY NO LATER THAN 10:00 AM the FOLLOWING MORNING.
- 5. No reservations will be made for July 4th weekend and Labor Day weekend.
- 6. No alcohol may be served to minors.
- 7. Any fires must be made in the grills or the fireplace.
- 8. Volume of music must be controlled at a reasonable level so as not to annoy the neighbors.
- 9. Affair or party must be over by 11:00 PM.
- 10. No fireworks at any time.
- 11. A deposit of \$150 is required seven days prior to reservation date, to be refunded after inspection of area shows clean-up complete and no damage to facility. Applicant is responsible for any damage to facility; C.B.P.O.A. will repair and bill applicant.
- 12. Approval of Board is required for any structure, tent or other article not presently on C.B.P.O.A property.
- 13. The beach sun shed will not be included in area of use.
- 14. Beach can be used for beach purposes only; no volley ball playing on beach.
- 15. East Hampton Town requires a Town Permit for gatherings of 50 people or more.
- 16. A Certificate of Insurance in the amount of \$1,000,000.00 must be submitted before the reservations date is confirmed. The Certificate must list CBPOA as <u>additionally insured</u>. This can be obtained from your Homeowners policy agency. IF LIQUOR IS TO BE SERVED, IT MUST INCLUDE LIQUOR LIABILITY. If an outside caterer is used, please be advised that a copy of his/her Certificate of Insurance in the amount of a million dollars must also list CBPOA as additionally insured.
- 17. Also, before your party date is confirmed, an indemnification and hold harmless agreement (copy attached) must be completed, signed and notarized by a notary public.
- 18. Picnic area reservations will be made available to Clearwater members in good standing and their immediate family members only.

Cooking Long Island's Bounty

With the longer days and warm sun, the seeds we put in the ground in early spring have germinated and are growing. Basil flourishes, and what better dish to prepare than one of my most favorite and easiest recipes—Genoese Pesto. This dish also uses one of our early vegetables, asparagus.

LINGUINE WITH GENOVESE PESTO

25 Basil leaves2 d5 Tbsp. extra virgin Olive Oil1/1/3 cup freshly grated Parmesan cheese12Pinch of salt11 to 2 small potatoes peeled and cut into sticks1/3 cup asparagus (green beans also work nicely)

2 cloves of garlic 1/3 cup of freshly grated Romano cheese 12 ounces of linguine

Put basil, garlic, olive oil, and salt into food processor and process at medium speed for a short time. Add both cheeses and process briefly. Cook the pasta, potato, and asparagus together until done. Toss together and serve while pasta is still warm.

Rabbit, a lean meat which has been neglected by Americans and is a favorite in Europe, can be purchased and prepared in the following savory dish.

RABBIT WITH ONIONS AND PANCETTA

One of the tastiest white-fleshed meats readily available, and highly neglected by Americans, is fresh rabbit. It is a favorite in my family and this is one of the best ways I have ever prepared it. By the way, dark meat chicken thighs (sans skin) can be substituted and works wonderfully well. I find all rabbit recipes are better when the parts are cut smaller than most butchers like to prepare it. So be prepared to get out the meat cleaver yourself or give the butcher very specific instructions!

fresh rabbit
 large onion, thinly sliced
 sprig of Rosemary, omit stem
 fresh Sage leaves
 about 2 tbs. of tomato paste
 a cup of decent quality white wine

¹/₄ cup of olive oil
2 thin slices of pancetta, minced
3 bay leaves
4 whole cloves
Salt and pepper to taste

Into a large Dutch oven put pancetta, onion, olive oil, herbs, and cloves and sauté over a moderately high heat, stirring frequently until onions wilt. Season the rabbit (or chicken) pieces with salt and pepper, and lightly brow meat on all sides. Add the tomato paste, coating the pieces of meat. Add the wine (make sure this is a wine you would drink), scrapping the bottom of the pan to amalgamate those tasty bits into your sauce. Add the stock and simmer, only slightly covered as you want some evaporation to occur. When the sauce is reduced and the rabbit is done (in about forty minutes), if the sauce appears a little too watery, remove the meat, set aside, and continue to cook until it thickens. I like to serve this dish with polenta or pappadella noodles.






